Role of Legislation

In India OTT platform is yet not having any regulatory authority. Unlike other media platform OTT platform is comparatively fresh in India. Its growing popularity among youth shows an urgent need to formulate rules and regulation for prevention, control and accountability of this platform. The content cover under OTT platform is more of sensitive and fearless and the language used is mostly abusive. Hence immediate establishment of law is the need of an hour. This will not only regulate the OTT platform but also been proved effective for the welfare of society in order to maintain the culture. The present government has shown the willingness on numerous occasions to intact the Indian culture and values. It is in this context; the ministry of Information and Broadcast (MIB) has emphasized on certain kind of regulation of OTT Platforms to rationalize the sector and convened consultations with numerous stakeholders. In this background, the MIB recently notified the Information Technology (Guidelines for Intermediaries and Digital Media Ethics Code) Rules 2021 (Rules). The new rules seek to maintain a balance between self-regulation and government control.²

Suggestion / Preventive method

- 1. Content cover under OTT platform must be free from violence, abusive language and objectionable material.
- 2. Web series or any film shown under OTT platform must have censorship certificate.
- 3. Regulating authority need to be established for maintain rules and regulation for this platform.
- 4. Privacy policy and accountability need to be maintained.
- 5. Strict action to be taken against infringement of copyright Act.
- 6. More of learning, sports, cultural, spiritual and educational content to be shown by this Platform.
- 7. Age restriction to be there to watch certain objectionable material.

Conclusion

With the advent of OTT platform and its tremendous growth in a short period of time, depicts its importance among youth and adult groups. Demand of OTT platform is slowly overtaking the conventional cinematic experiences and its popularity. The present and the upcoming generations have lost interest in interacting at a social platform through cinema, rather choose to remain indoors at their comfort zone on couches and travel throughout the globe using their screens. There is a shift in the use of technology as well. It can be seen how technology was used in the earlier times as a
