OTT has a major influence on behavioral and social changes, especially in teenagers and youth. With the regulation of OTT platforms, OTT service providers have taken a stand against censorship addressing their right to freedom of speech and expression. Thus OTT can be recognized as a significant medium for the communication of ideas that might be affecting public attitudes as well as behavior in different ways. Any kind of violence against the general public is not reinforced under the right of expressing views or opinions by anyone. OTT platforms like Netflix, Big-Flix, Amazon Prime, and Disney+ Hotstar are major players that also encouraged other national broadcasts to jump into this lucrative revenue model, and Alt-Balaji, ZEE5, Voot, and other regional platforms are introduced to viewers making them easier in choosing desired content. It has enhanced OTT's share in the market which is considerably high. It has promoted accessibility across the nation as well as worldwide encouraging knowledge, tolerance, and respect for diverse people and practices. It is a free expression of ideas, knowledge, and views making global unity through silent influencing content. OTT has been enhanced access to other cultures sensing the borderless mechanism through audio-visual content.5 According to the study on OTT censorship laws, free exchange of ideas is important for the healthy development of society. It allows the free flow of ideas, views, and information with freedom of speech and expression given by democracy. Its value is maintained with the assurance of selffulfillment, including social, and political participation and decision-making. India as a democratic country provides special attention to protect these rights to freedom of expression without interference to pursue, receive and convey information and thoughts through any media. Every citizen secures their fundamental rights in democracy and OTT is a crucial part of implementing these rights. Audio visual content on OTT not only expresses the views of an individual but also influences the people to make their own views. In the modern digital age of entertainment, OTT content is incorporated with social, historical, cultural as well as historical content which has become an inspiration with a sense of humanity in people. However, some of the content is too sensitive to create hatred among society against thoughts, people of a particular community, or categorize. The study highlights the role of OTT in society with increasing cases of demands against content released which results in the possibility of revolt in the society. 6

A study highlights the need for protecting the rights of OTT to freedom of expression accounting benefits of the platform. The increasing popularity of the OTT platform highlights these benefits in terms of conveying information and the availability of content. Despite several countries denying the regulation of OTT platforms to secure freedom of creativity and expression, India has regulations under some other forms while it is difficult to regulate internet content. Self-regulatory bodies can sign a code of best practices with OTT service providers. The study looks into the OTT practices of regulating the content and concludes the self-regulation of OTT content is the way to ensure ethical issues and responsibilities in conveying the content. 7

Another study on OTT explains the need for censorship and states that content causing an outrage in the society is involved in the censorship process of deletion of content. The study implies that reasonable restrictions properly balance liberty and social interests and hence censorship is reinforced to maintain this balance.8

An Overview of Indian Censorship is studied in terms of races, civilizations, and religious figures to live in peace. They can express in mythical, artistic, or cinematic form while it is supposed disagreeable to others at one time or another. Despite the right to freedom of speech and expression being the basis of Indian democracy, it is subject to certain limitations. If these expressions offend any religious feelings or create or promote animosity, hostility, or unkind determination amongst a community of different caste, religions, language, or race, then the Indian Penal Code (IPC) consents to restrictions on freedom of speech and expression. The study found these prohibitions largely categorized, and difficult to judge if it does not foster hatred between communities. However, freedom of speech in significant expression empowers democracy to function properly allowing the spread of ideas among the citizens for the purpose of awakening thoughts, and proper exchange of ideas. Thus anyone can express views on public policy or provide feedback to legislators. But the censorship is an essential part of protecting a community from offense to their sensibilities.

The study explains the limitations of Freedom of speech and expression for enmity, indecency, or upset religious sentiments highlighting the need for censorship to avoid cases of spread of communal violence. Though it feels but is not to inhibit freedom of expression. It is important in the digital era where negative expression is spread over the various platforms to stimulate hostility among teenagers and youth against the nation. It is easily reaching youth through the access of inconvenient and adult content on the OTT platform though it requires parental permission. OTT content is not restricted to watching by immature age viewers including teenagers or children. However, OTT content has access on subscription on-demand allowing anyone to watch whatever is selected. This is the biggest dispute to raise the need for censoring the content on OTT with another perception that rural viewers are not aware of regulating the content that should not be accessed by children. The increase in OTT users has also raised some issues of knowledge of the regulation of content and drawbacks of easy access to troublesome content. The global OTT platform is also restricted by some countries except a few countries. The study explains the different contents and their restrictions without suppressing the fundamental rights. Therefore, the researcher has also studied different OTT platforms and their impact on the entertainment industry other than OTT.

Findings/Discussion

Today, the internet has transformed the technology uses with huge transformation in several business sectors and almost captured high market value with commendable revenue. OTT platform is one of the biggest entertainment sectors getting enormous success. Reliance Jio is one of the major promoters of Internet and OTT platforms. Also, the easier investment facilities attracted foreign investments in India while the major revenue-collecting entertainment industry is the best choice for such investments. The researcher found that large youth in India spending their time on the OTT platform has attracted greater national and international service providers including regional service providers. 10

Several countries like Australia have taken action with a code of practice against digital content or disinformation and digital platforms also agreed to a selfregulatory code that prevents serious harm through content. India is also bound to democratic values that influence the policies. Considering freedom of speech and expression, OTT must follow the law of land as freedom comes with reasonable restrictions. As a vibrant democracy composed of several communities with different social, economic, political, and religious complexities, the internal peace of India is a major concern. That is why constitutional freedom of expression is combined with restrictions. Several cases in courts also specify the need for regulation and like other countries, India has its own rules and international companies cannot assume their own views over freedom of expression.13

The new IT act has expanded the OTT regulation scope of self-regulation with the three-level framework. The grievances are powered by the interdepartmental committee and non-judiciary adjudicatory body. But the digital OTT platforms like The Wire, Quint Digital Media, and others claimed the regulations are enforced with an unclear Code of conduct. For the multi-religious and multi-racial community, India has proposed a Code of ethics for OTT platforms. OTT platforms must exercise discretion and due caution in case of presenting sensitive content, especially related to religious or racial beliefs and community practices or views. But to protect artistic freedom, investors opposed the censorships with substantial condemnation. On the other side, recent issues of OTT content point out cultural and religious feelings and protests raised against depictions of sexuality. Cumulative demands for the restriction against OTT platforms for communal, religious beliefs, and cultural ethics are rising and monitoring and control with censorship are proposed against the freedom of OTT platforms.

IT rule is focused on the digital platform including social media and OTT platforms for discretion and domestic security concerns. It is aimed to tackle false, hatred, and illegitimate content in addition to unwanted and offensive content on new-age media and video streaming platforms. New rule guidelines work on the regulation of rapidly growing and powerful internet companies to protect the public sphere.
