In addition to formal judicial and non-judicial proceedings; People-centered justice services include a growing range of processes and procedures: alternative mechanisms for dispute resolution such as mediation, conciliation, online dispute resolution system, paralegal services, public legal education providers, community advocates, collaborative service provision from legally-trained and other professionals, and pre- and post-resolution support.

• How legal empowerment plays important role in achieving access to justice for all?

Legal empowerment happens when marginalized people or groups use the legal assemblage i.e., law, legal systems and justice mechanisms to get better or transform their social, political or economic conditions. Legal empowerment tries to solve people's daily problems of injustice, including intra- community disputes and rights abuses that arise from traditional authorities, state institutions and private firms. Legal empowerment perspective usually depends on five categories

of tools: legal awareness raising, legal service provision, dispute resolution, law reform initiatives, and litigation.

Impact of legal empowerment in various nations:

It must be say that due to the legal empowerment approach to access the justice were resulted in the effective manner and can see it in different geographies as follows:

- In Indonesia, one of the local NGO used female paralegals to spread out understanding female-headed about rights and entitlements in households. Along with international partners, the NGO supported government reforms of state and religious justice institutions by creating and raising awareness and assisting with women's cases, contributing to a fourfold increase in the number of women able to access circuit courts the subsequent year.
- In Ecuador, the World Bank evaluated five legal service centers focused on enforcing child support payments for poor and needy women and reducing domestic violence cases. The study found that the centers' clients seeking child support were more likely to succeed than those without access to legal aid. They were also less likely to experience physical violence after separation from their partners.
- In India, filing applications under the Right to Information Act (RTIA) has helped New Delhi's slum dwellers to acquire ration cards for subsidized foodstuffs. It has subsidized the cost of litigation.
- In Sierra Leone, extended or unlawful pretrial detention damages the prosperity and health of prisoners and their families. An Oxford University study showed that a program placing paralegals in prisons to provide free legal services has reduced the numbers of prisoners held on remand by 20% and increased the percentage gaining access to bail by 13%. Moreover, only two paralegals placed at each police station managed to provide basic legal advice to 70% of detainees.⁴

3 Conclusion

Sustainable development goals ensure that all the people enjoy peace and prosperity in present and in future. The aim of SDG 16 is ensuring peaceful and inclusive societies for all, providing equal access to justice for all and to build accountable and inclusive institutions at all levels. Social justice is the view that everyone deserves equal economic, political and social rights and opportunities.
