The another question related to facing difficulty in adopting technology, out of the total sample size of 100 %, 60 % of the population i.e. out of 100 students, 60 students did not face any difficulty and got easy adaptation to the technology, whereas 40 % i.e., 40 students faced difficulties in adopting the technology because of some technical glitches (being unable to join the lecture after repeated requests), foremost obstacle for the students became connectivity issue and network problem.

Further on the question related to the affect of online mode of education and lock down specifically, out of the total sample size of 100 %, 55 % of the population i.e. out of 100 students, 55 students have been affected by the lockdown or either online mode of education in following ways:-

Lazy and lethargic attitude has gradually developed towards the studies, with no growth and development in oneself.

Faced financial issues.

Online lectures didn't work well because of connectivity issues

Quality of education dropped drastically, concentration power also decreased.

Lockdown taught many important life lessons

Online education has completely precluded social development

Affected field visit and Internships

Practical knowledge lacking because of online mode of education

45 % i.e. 45 students out of 100 say that they have not been affected by lockdown or either online mode of education.

View on the very next question related to conducting exam and other practical aspects through online mode, out of the total sample size of 100 %, 65 % of the population, i.e. out of 100 students, 65 students don't find the online mode of education to be feasible mode for conducting practical aspects or exam due to the following reasons:

Server down or network problem makes it difficult at times for submission of the assignments.

Not justifiable as immoral activities are involved during online exams like cheating and copying.

Do not bring out the best as only visuals are known and not other minute details.

This online mode of exam is gradually decreasing thinking capacity

High leniency and students taking undue advantage of the situation.
