#### THE BARVE DEFAMATION CASE

Those were the times when people liked the princely states and their rulers and any injustice or wrongdoing in this regard was newsworthy. The states of Kolhapur and Baroda were administered by Diwans appointed by the British government as the heirs to the thrones were minors. Some letters [which later turned out to be forged] were published which alleged that the administrators namely T. Madhavrao administering Baroda and M. N. Barve administering Kolhapur were not acting in the best interest of the Maharaja. Barve then instituted a defamation suit which Tilak and Agarkar lost as the letters they had relied on turned out to be forged. They tendered unconditional apologies but Barve was not satisfied and the judge held them guilty of the charges of defamation and sentenced them to four months' rigorous imprisonment.

Tilak and Agarkar served their sentence in the Dongri prison as common convicts as there was no separate class as political prisoners. Despite appealling condition in the prison, the two served out their 101 days [shortened for good behavior] quite cheerfully and utilized the time for more discussions on subjects dear to their heart.

It is worth mentioning that as soon as the legal proceedings started, the students of Deccan College [where Tilak and Agarkar had studied] and the New English School rallied around the young newspapermen and collected a fund to aid in their legal defense since the two had very limited resources. What is noteworthy is the fact that even in those early years Tilak and Agarkar inspired the people and were showing signs of their leadership abilities. That they were becoming popular is beyond doubt. Upon their release, people greeted them
